AN ORDINANCE OF THE BOROUGH OF HANOVER, YORK COUNTY, **PENNSYLVANIA AMENDING** ORDINANCE NO. 2188 BY AMENDING CHAPTER 346, SECTION 14 THEREOF IN ORDER TO ADD BRANDYWINE COURT AT THE INTERSECTION OF A PUBLIC ALLEY FROM PAUL STREET AS A STOP SIGN INTERSECTION AND MAKING SUCH INTERSECTION SUBJECT TO ALL MUNICIPAL AND STATE LAWS, ORDINANCES AND REGULATIONS APPLICABLE TO STOP SIGN INTERSECTIONS IN THE BOROUGH OF HANOVER AND COMMONWEALTH OF PENNSYLVANIA.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Hanover, York County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. Ordinance No. 2227 is hereby repealed.

SECTION 2. Ordinance No. 2188 is hereby amended by amending Chapter 346-14 thereof in order to add the following as stop sign intersections:

- a.) "A stop sign except right turn" sign shall be placed on Brandywine Lane going in a southerly direction at the intersection of the unnamed alley connecting Brandywine Lane to Paul Street.
- b.) A stop sign shall be placed on the unnamed alley connecting Brandywine Lane to Paul Street going in a northerly direction at the intersection of unnamed alley and Brandywine Lane.

SECTION 3. All of the regulations applicable to stop sign intersections in the Borough of Hanover as set forth in Chapter 346-14 of the Code of the Borough of Hanover and all statutes, ordinances and regulations of the Commonwealth and the Borough of Hanover applicable to stop sign intersections and the movement of vehicles approaching and passing through same shall be applicable to the above listed intersection.

AND THEREBY OPENING SAID STREET AS A PUBLIC RIGHT-OF-WAY.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Hanover, and it is hereby enacted and ordained by the authority of same as follows:

SECTION 1. The Borough Council of the Borough of Hanover hereby accepts the deed of dedication of Stone Ridge Development Corporation, for Stonecroft Drive, as shown on the Final/Preliminary Subdivision Plan of Stonecroft, prepared by Worley Surveying, dated March 25, 2005, bearing Job No. 4071-05, and recorded in the Recorder of Deeds Office in and for York County in Land Record Book 1783, Page 3961, et seq.
