YARD SALE POLICY

1. Sale can only be conducted between the hours of 9:00 AM and sunset.
2. Sales cannot be for more than two (2) consecutive days.
3. No Sunday sales.
4. No person shall be issued more than two (2) permits within a calendar year for any one property.
5. No refrigerators or iceboxes having a capacity of one and one-half (1½) cubic feet or more, with an attached lid or door that may be opened and fastened shut by means of an attached latch, lock, or other similar device, shall be displayed, offered for sale, or sold at a private auction unless the attached lid or door shall first be removed and detached thereof or secured in such a manner that the door cannot be closed.
6. No food, whether hand-prepared or packaged, is permitted for sale. Canned soft drinks, bottled soft drinks and like beverages, and bottled water are permitted for sale. No hand-prepared beverages or any alcoholic beverages are permitted for sale.
7. Please be advised that it is illegal, per Borough Ordinance 1643, to post signs on trees, utility poles or any other sign or structure in the public right of way in the Borough of Hanover. The public right-of-way is that area from the inside edge of the sidewalk to the curb.
8. If inclement weather would cause you to cancel a scheduled yard sale, no refunds will be provided. However, provided you notify our office and return the permit within 24 hours following the scheduled sale date, we can reissue the permit for another day within the calendar year.
9. The fee for a yard sale permit is \$5.00.
