BOROUGH COUNCIL ACTIONS AND ANNOUNCEMENTS:

CODE ENFORCEMENT OFFICERS: Mayor Whitman administered the Oaths of Office for Christopher S. Miller, Dominic DellaVecchio, and Lauri Becker.

DISPOSITION OF RECORDS: Per Resolution No. 1363, approval was granted to dispose of records according to the Municipal Records Manual of the PA Historical and Museum Commission.

SEWER BILLING CREDITS: Per Resolution No. 1067, Chick-fil-A was granted the requested sewer billing credit.

TRACTOR SUPPLY TIME EXTENSION: Time extension for review of Preliminary / Final Subdivision & Land Development Plan until March 28, 2023, was granted.

DESIGNATION OF POSITION: Approval was granted for the designation of a Wastewater Pretreatment Officer in the Department of Water Resources, Division of Wastewater Treatment, per *Pennsylvania Borough Code*.

YMCA SUMMER AGREEMENT: Approval was granted for the Hanover Area YMCA Children's Summer Recreation Program Agreement.

AMENDED RULES FOR PUBLIC MEETINGS: Approval was granted for Resolution No. 1364 amending the Rules of Public Meetings.

FRINGE BENEFIT POLICY: Approval was granted for the Taxable and Non-taxable Fringe Benefits Policy per the *Internal Revenue Code*.

BROOKSIDE WATER SYSTEM DEDICATION: Approval was granted to accept the offer of dedication of the water system and related appurtenances for the Brookside residential development, contingent on satisfactory completion of items outlined by the Director of Planning & Engineering.

RH SHEPPARD CO., SUBDIVISION PLAN: Approval was granted for Resolution No. 1365 for the Preliminary / Final Subdivision Plan for RH Sheppard Company, Inc.

NOTICE OF INTERVENTION: Approval was granted to authorize the Solicitor to file a Notice of Intervention in the matter of Mark A. Kauffman and Tammy S. Gobrecht v. Hanover Borough Zoning Hearing Board.

ADVERTISEMENT OF ORDINANCE: Approval was granted to advertise an ordinance to eliminate 2-(two-) hour parking on the north side of Chestnut Street near the intersection of Railroad St.

AUTOMATIC RED LIGHT ENHANCEMENT GRANT: Approval was granted for the proposal and contract for survey and base map preparation by Transportation Resource Group (TRG) and Hanover Land Services (HLS) in coordination with the Automatic Red Light Enhancement (ARLE) Grant Project.

ENHANCEMENT COMMITTEE CITIZEN ADVISORS: Approval was granted to designate the term of citizen advisors for the Hanover Enhancement Committee to 2 (two) years until December 31, 2024.
