BOROUGH COUNCIL ACTIONS AND ANNOUNCEMENTS:

PRESENTATION: Certified Park and Recreation Professional Ann Toole and Andy Mears of Toole Recreation Planning presented results of a comprehensive study of Hanover's parks and recreation resources.

OATH OF OFFICE: Mayor Whitman administered the oath of office to Karrie Brinson as Code Enforcement Officer.

CONSULTING CONTRACT: Ratification of the contract for consulting services for the Rental Property Registration/Inspection Program was denied by roll call vote.

SOCIAL MEDIA POLICY: Approval was granted for the Borough's Social Media Policy.

SEWER CREDITS: Approval was granted for sewer credit requests per *Resolution #1167* for: Sensenig Real Estate, LLC (427 ½ Carlisle St.) for \$2,028.85.

LIBRARY DIRECTOR & LIBRARY FUNDRAISING & DEVELOPMENT MANAGER: Salaries were approved by resolution.

BOROUGH SEWER RATES: Approval was granted for *Resolution No. 1383* establishing the Hanover Borough Sewer rates effective January 1, 2024.

SCHEDULE OF FEES: Approval was granted for *Resolution No. 1384* revising the schedule of fees for permits, licenses and services provided by the Borough of Hanover, effective January 1, 2024.

ADVERTISEMENT OF ORDINANCES: Approval was granted to advertise Ordinances establishing in-Borough water rates for 2024 and levying taxes for 2024.

TEMPORARY LOAN TO WATER FUND: Approval was granted for a temporary loan from the General Fund to the Water Fund in the amount of \$1,500,000.00.

ORDINANCE REVISING PARK RULES: Approval was granted for *Ordinance No. 2344* to eliminate the allowance of open burning and the disposal of hot coals from charcoal grills in public parks.
