



In compliance with the requirements of the Municipality Authorities Act, Act of May 2, 1945, P.L. 382, 53 Pa. C.S.A. §5601 et seq., as amended, and pursuant to the desire of the duly elected officials of the Borough of Hanover, York County, Pennsylvania, signified by duly enacting Ordinance No. 2277 of the Borough of Hanover authorizing the organization of a Municipal Authority and the obtaining of a Certificate of Incorporation to be issued to said Authority, the Borough of Hanover does hereby certify:

a. The name of the Authority shall be "Borough of Hanover Stormwater Authority", and the registered office of the Authority is 44 Frederick Street, Hanover, York County, Pennsylvania 17331;

b. The Authority is formed under the provisions of the Pennsylvania Municipality Authorities Act, 53 Pa. C.S.A. §5601 et seq., as amended, Act of May 2, 1945, P.L. 382, and its various amendments;

c. No other Authority has been organized under the Municipal Authorities Act of 1945 or under the former the Act of June 28, 1935 (P.L. 463, No. 191) and is in existence in the Borough of Hanover;

The purpose of this Authority is to provide the financing, operation, and maintenance of a comprehensive Stormwater Management System, including underground pipes, conduits, inlets, outfalls, culverts, catch basins, dams, flood control structures, gutters, ditches, channels, detention ponds, best management practices, public streets, curbs, conveyances, appurtenances, and drains and to establish reasonable and uniform rates based in whole or in part on property characteristics for the inhabitants of the Borough of Hanover. For such purposes, the Authority shall have and exercise all powers granted by law pursuant to the Municipalities Authorities Act; and


g. The Designated Service Area for the Authority is the Borough of Hanover, York County, Pennsylvania.
